Summary of Incident:

On 7/17/2025, a deputy contacted a female suspect with three outstanding Marin County Warrants. The suspect was also on active Marin County Probation. The deputy contacted the female, advised her of the outstanding warrants. The suspect immediately became defensive, told the deputy he could not arrest her and walked away from the deputy. The deputy attempted to take control of the suspects twice to place her in handcuffs, but the suspect pulled away and walked away both times. The deputy gave repeated commands to stop walking away and advised her multiple times she was under arrest.

The deputy again tried to grab ahold of the suspect's arm, she pulled away and punched him in the arm. Due to the suspect punching the deputy, her refusal to obey lawful commands, her aggressive demeanor, and the deputy being alone at the time of the incident, the deputy drew his CEW, activated it and aimed the laser at the suspect in an attempt to gain compliance. The deputy briefly holstered the CEW and continued to attempt to de-escalate the situation. Ultimately the suspect ignored commands, walked away from the deputy before she changed direction and walked aggressively toward the deputy. The deputy drew his CEW, aimed it and fired it at the suspect. The CEW caused the suspect to fall to the ground, and the deputy was able to take the female into custody. The suspect was arrested for 148(A)(1) PC, 69 PC, 1203.2 PC

On 7/29/2025, detectives were helping another law enforcement agency locate a suspect who had just committed the offense of 245(a)(2) PC. Detectives observed the suspect as a passenger in a vehicle. The detectives observed the vehicle drive into a gas station and park at a pump. The suspect exited the passenger side and looked directly at the detectives who were parked in a nearby undercover vehicle. Detectives were fearful that the suspect was going to draw a weapon at them as they observed the suspect reaching around his waistband. Given the escalating situation and the concern for public safety, detectives exited the unmarked patrol vehicle to detain the suspect. Detectives gave a lawful order for the suspect to stop reaching in his waistband, but the suspect refused to comply with orders and continued to reach towards his waistband. A detective drew his department-issued CEW, activated the warning arc, and pointed it towards the suspect. The suspect complied and lay down on the ground, where detectives were able to place the suspect under arrest without incident for 245(a)(2) PC.

Offense(s): 148(A)(1) PC and one outstanding out-of-country warrant for 459 PC and 487 PC

Summary of Incident:

On 8/9/2025, a deputy was on routine patrol when he observed a subject he knew from previous contacts that had an outstanding out-of-court warrant for 459 PC and 487 PC. The deputy approached the subject, who began to run away. Based on this active flight and apparent intent to delay and resist arrest, the deputy began to chase the suspect. The deputy caught up with the suspect and drew his CEW while ordering the suspect to the ground. The deputy delivered a one-handed push to the suspect's back, directing him onto the ground. Once on the ground, the deputy arrested the suspect for 148(A)(1) PC and one outstanding out-of-country warrant for 459 PC and 487 PC without further incident.

Offense(s): 148(A)(1) and three outstanding out-of-country warrants for 273.6 PC, 148(a)(1) PC,

and 601.1(a) PC.

Summary of Incident:

On 8/18/2025, deputies were dispatched to a report of an unwanted subject. Deputies identified the suspect from previous contacts and located three warrants for her arrest out of another county. Deputies were unable to locate the suspect on that date.

On 8/21/2025, deputies were dispatched to the report of a suspicious female who was possibly squatting at a residence that was for sale. Deputies suspected the subject was likely the same suspect from 8/18/2025 based on the recent incidents involving her in the area and the fact she matched the subject's description.

A deputy located the suspect nearby and attempted to detain her. The suspect did not follow orders and began screaming and yelling. The suspect then ran away from the deputy through a busy shopping center. The deputy drew her taser, activated it, and pointed it at the suspect in an attempt to gain compliance, which was unsuccessful. At this time, an officer from a nearby law enforcement agency arrived to assist. The deputy arrested the suspect without further incident for 148(A)(1) and three outstanding out-of-country warrants for 273.6 PC, 148(a)(1) PC, and 601.1(a) PC without further incident.

Offense(s): 245(c) PC 243(c)(1) PC, 148(a)(1) PC, and 69 PC.

Summary of Incident

On 9/26/2025, deputies were dispatched to a report of a suspicious person on a private driveway. Deputies arrived and located the suspect. Upon engaging with the suspect, the suspect would not provide his name and made nonsensical statements. Based on nonsensical and paranoid statements, his inability to answer simple questions, deputies attempted to evaluate him to determine if her met the criteria for a 5150 W&I hold.

As deputies were attempting to ask him further questions, he began rummaging around in his cart where deputies could see multiple dangerous items such as scissors and a multi=purpose tool attached to the suspects neck. Deputies gave him commands to stop reaching in the cart or he would be placed in handcuffs. The suspect did not comply while yelling at the deputies. Due to his refusal to follow directions, deputies reached to place him in handcuffs. The suspect pulled away from the deputies and punched one deputy in the face with a closed fist causing him to later need two sutures. The deputies attempted to gain control of the suspect, but he was able to get ahold of the tool around his neck and hold it in his hand.

Due to the violent resistant, the assault on the deputy, and the potential weapon in the subject's hand, one of the deputies took the suspect to the ground while the second deputy drew her CEW, activated it and pointed it at the subject. Due to the multiple layers of clothing worn by the suspect, the deputy determined the CEW may not be effective and holstered the CEW. Additional deputies arrived and they were able to place the suspect into handcuffs. The suspect was ultimately identified and arrested for 245(c) PC 243(c)(1) PC, 148(a)(1) PC, and 69 PC.

Offense(s): 148(a)(1) PC, 2800(a) PC, 21201(d) CVC, and 11377(a) HS

Summary of Incident

On 9/28/2025 at approximately 0004 hours, a deputy was on patrol when he observed a subject riding a bicycle without lighting equipment or reflective gear in violation of 21201 CVC. The deputy conducted a stop on the bicycle and approached the subject while advising him he was being detained. The suspect ignored the deputy's commands and fled on his bicycle. The deputy terminated his bicycle stop.

Deputies located the subject again riding the bicycle without lighting equipment. The deputy again attempted to stop the bicycle, activating his siren and forward-facing red lights. The subject again fled from deputies in violation of 148 (a)(1) PC. One deputy engaged in a foot pursuit with the suspect. Due to the suspect resisting the deputies' attempts to stop him, the unknown identity of the suspect, and because he was unable to determine if the suspect was armed with any weapons, the deputy drew his department issued CEW, activated it and

pointed it at the suspect. The suspect ignored commands and fled, ultimately evading the deputy again.

Deputies were ultimately able to detain the subject nearby and arrested him for 148(a)(1) PC, 2800(a) PC, 21201(d) CVC, and 11377(a) HS.
